### **B-HIPP (Maryland Behavioral Health Integration in Pediatric Primary Care)**

*Maryland Behavioral Health Integration in Pediatric Primary Care (B-HIPP)* aims to support the efforts primary care providers (PCP), including pediatricians, family physicians, nurse practitioners and physician's assistants, in assessing and managing mental health concerns in their patients from infancy through the transition to young-adulthood. B-HIPP provides 1) **phone consultation service** between PCPs and child mental health specialists; 2) **continuing education** for PCPs to build their skills; 3) **referral & resource networking** by increasing linkages between PCPs and other community-based services; 4) **social work co-location** pilot in Salisbury placing social work interns in four pediatric practices.

### **Catastrophic Illness in Children Relief Fund**

***Catastrophic Illness in Children Relief Fund*** is a financial assistance program for families whose children have an illness or condition otherwise uncovered by insurance, State or Federal programs, or other source, such as fundraising. The Fund is intended to assist in preserving a family's ability to cope with the responsibilities which accompany a child's significant health problems. Currently two states (NJ & MA) have such plans.

### **Children's Developmental Clinic**

The *Children's Developmental Clinic* is for children birth through twelve years of age who are experiencing a delay or disability in the following: gross and fine motor development, receptive and expressive language, reading development and social skills. The Children's Developmental Clinic provides services for children in the areas of motor, language, reading and social skills. A nine week session is available during the fall and spring semesters at Prince George's Community College (PGCC) and the University of Maryland. A five week summer session is also available at PGCC. Parent education is a requirement of the program. Fees are included. The Community College of Baltimore County (CCBC) also has a clinic.

### **Family-Led Policy Influence**

*Family-Led Policy Influence* refers to a grassroots, family-led advocacy network that focuses on policy issues such as adequate insurance and financing for children with ASD or other DD. Ideas include hiring a policy coordinator to build a "policy influence" infrastructure for CYSHCN issues in Maryland. Main functions would be to facilitate the training of families to be comfortable meeting with legislators; make sure families have meetings with their legislators; track these meetings, get information out to families when specific legislation is being considered that would impact CYSHCN, mobilize those families and support families contact their legislators about specific legislation. by Parents' Place is such a network that could be expanded. Goals include to: 1) Educate legislators & regulatory agency on the costs incurred by families with children with special health care needs & the effects of lower reimbursement rates on the availability of service providers; and 2) Include families of CYSHCN on decision-making bodies charged with determining levels of mandatory coverage of CYSHCN.

### **Health Enterprise Zone (HEZ) in Prince George's Health Department, *Capitol Heights***

The proposal submitted by Prince George's County Health Department focuses on Capitol Heights, a neighborhood that leads the county in poor health outcomes, including low birth weight, late/ no prenatal care, and teen births, and is comprised of 95 percent racial/ ethnic minorities. This proposal would create five new patient-centered medical homes in the Zone to serve a minimum of 10,000 residents, and would add a total of 25 new providers.

### **Maggie's Light Foundation**

***Maggie's Light Foundation*** is a Maryland non-profit organization which supports Maryland families, caring for their children and young adults with special needs. Their primary focus is respite care.

### **Medicaid Buy-In**

A *Medicaid Buy-In* program allows families of children with special needs to 'buy-in' to Medicaid coverage for a child even though they don't financially qualify. Five states currently have this option for families of CSHCN.

### **Medical Home**

A family-centered *Medical Home* is not a building, house, hospital, or home healthcare service, but rather an approach to providing comprehensive primary care. In a family-centered medical home the pediatric care team works in partnership with a child and a child's family to assure that all of the medical and non-medical needs of the patient are met. Maryland began a 3-year program, the Patient Centered Medical Home (PCMH), to test this new model of care in 2011, with 52 primary and multispecialty practices and federally-qualified health centers (FQHCs) located across the state.

### **Multi-Disciplinary Clinic**

A ***Multi-Disciplinary Clinic*** offers families an opportunity to see many different providers in one place at one time for multidisciplinary team evaluations or services.

### **Provider Training**

*Provider Training* involves training primary care providers; allied health/habilitative services providers (OT, PT, Speech, etc); school teachers, staff, and administrators; child care and respite care providers on:

1) how to best meet the needs of children with ASD/DD and their families; and 2) medical billing and coding.

### **Regional Hub**

A ***Regional Hub*** is a central point for assistance in accessing services, information, and resources.
